NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

NOTE 1. SIGNIFICANT ACCOUNTING POLICIES

The financial statements cover Mallacoota & District Recovery Association Incorporated (the Association) as an individual entity. Mallacoota & District Recovery Association Incorporated is a not for profit association incorporated in Victoria under the Associations Incorporation Reform Act 2012 (the Act).

Comparatives are consistent with prior years, unless otherwise stated.

Basis of Preparation

These special purpose financial statements have been prepared to meet the reporting requirements of the Act.
